I. AWARDS OF THE AIR MEDAL:

By direction of the President, under the provisions of Executive Order No. 9158, 11 May 1942 (Bull. 25, WD, 1942), as amended by Executive Order No. 9242-A, 11 September 1942 (Bull. 49, WD, 1942), an Air Medal is awarded by the Commanding General, United States Army Forces in the South Pacific Area, to the following-named officers and enlisted men for meritorious achievement while participating in sustained aerial flights on transport missions. These flights were performed in combat areas where there was a possibility of enemy interception. Their services reflect great credit on the Army Air Force.

WILLIAM D. FENNELL, (O-729153), Captain, Air Corps, United States Army, as pilot from 15 May to 16 September 1943. Home Address: Fresno, California.
